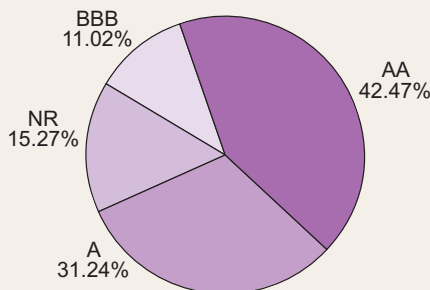

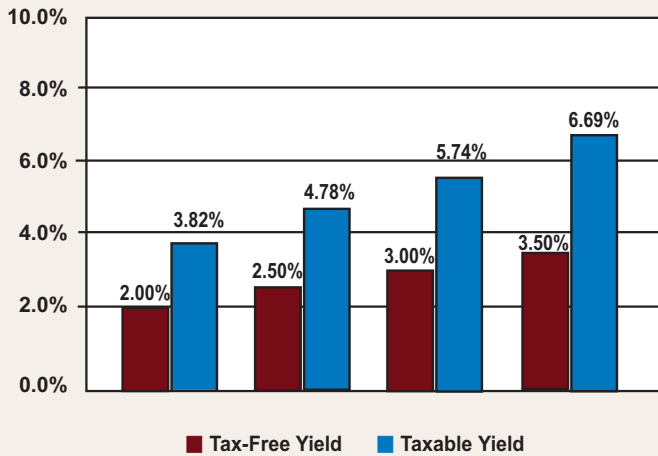

*The Fund's investment adviser has contractually agreed to waive fees and reimburse expenses through April 29, 2019 so that Total Annual Fund Operating Expenses After Fee Waivers and Expense Reimbursements (excluding taxes, brokerage fees, commissions, extraordinary and non-recurring expenses, and acquired fund fees and expenses) do not exceed 0.98% for Class A Shares and 0.73% for Class I Shares of average daily net assets. This expense limitation agreement may only be terminated or modified prior to April 29, 2019 with the approval of the Fund's Board of Trustees.

Taxable Equivalent Yields



The Taxable Equivalent Yields chart shows the estimated yield required from a taxable investment to match the yield from a tax-free investment, i.e. 2.50% = 4.78%. The chart assumes a maximum federal income tax rate* of 40.80% and a state tax rate of 6.90%. It is for illustrative purposes only and is not indicative of past or future performance of the Fund. After-tax returns are calculated using the highest historical individual federal marginal income tax rate and do not reflect the impact of local taxes. The taxable and tax-free yields reflect all applicable charges of the Fund. All returns assume reinvestment of dividends and capital gains. Lower maximum tax rates on capital gains and dividends would reduce the difference between the taxable and tax-free yields shown above.

All or a portion of the Fund's dividends may be subject to state and local taxes, and where applicable, federal alternative minimum tax (AMT). Actual after-tax returns depend on an investor's tax situation and may differ from those shown. You must consider your own personal investment horizon and income tax brackets, both current and anticipated, when making an investment decision. After-tax returns shown are not relevant to investors who hold their Fund shares through tax-deferred arrangements, such as 401(k) plans or individual retirement accounts.
